

## Millennium One Step™ Ultra Drive and Heavy Duty Manual Applicators

### Description

Millennium One Step™ Ultra Drive (Orange) and Heavy Duty (Black) Manual Applicators are designed to be used with Millennium One Step™ Foamable Adhesives. They are powered by manually squeezing the trigger on the handle of the applicator which drives the piston rods.

The Ultra Drive Manual Applicator is a premium quality hand tool manufactured in the U.S.A. which produces approximately 1,100 pounds of thrust. The Heavy Duty Manual Applicator produces approximately 900 pounds of thrust.

### User Instructions

1. Install mixing nozzle on cartridge. Prepare cartridge for loading according to adhesive manufacturer recommendations.
2. Ensure the piston rods are fully retracted. Place the rear of the cartridge over the pistons and then lower the front of the cartridge into the carriage and line up mixing nozzle opening.
3. Once the cartridge is loaded into the applicator draw the pistons up to the cartridge seals (plungers) by pushing on the piston rack. Squeeze the trigger located on the handle to begin dispensing adhesive.
4. To stop, release the trigger and press the thumb activated release located on the back side of the handle to relieve pressure.
5. To retract the pistons, simply press the thumb activated release button and pull back upon the piston rack until it is fully retracted.

### Maintenance Instructions

- Keep the applicator clean. Remove adhesive and/or contamination from pistons and drive rods before it hardens. Do not allow cured adhesive to build-up on pistons.
- Check the pistons and all fasteners routinely for tightness and proper function.
